Director of Accounting Services, Carlene Feichter proposed BP 3E6, which is a new board policy created to meet state requirements for the oversight of the data submitted for the CCFS-320 apportionment process. The KCCD draft budget for 2020-21 will reflect the Governor's May Revised budgetary impacts partial due to the COVID-19 crisis. The state is looking at a \$54 billion projected shortfall. Chancellor Burke will continue to determine impacts on the District's budget, and present to the Board in July 2020 instead of June 2020 due to an extension provided by the state.
