








# Guided Pathways Pillars

# Purpose and Goals

- 1) Position colleges to evaluate instructional effectiveness, and thereby provide assessment data and other accountability and reporting measures to empirically demonstrate the quality of instruction and the quantity of learning occurring at each college.
- 2) Support colleges in identifying and measuring one aspect of ensuring learning (e.g.: work-based learning, online learning, social capital, sense of belonging, and dual enrollment)
- 3) Coordinate with college teams to facilitate collaborative discussion on:
  - -Identifying goals and determining a Pillar 4 project
  - -Develop solutions to ensure learning
  - -Develop a timeline and checkpoints along the way









### 3-Year Timeline

- The process of ensuring student learning cannot happen with a singularity of effort but must be a long-term initiative.
- We invest in this 3-year journey without the pressure or expectation of yielding immediate results.
